

# Llanfyllin & District MCC

## Time and Observation Trial 30<sup>th</sup> May 2011

Announcement:- Llanfyllin & DMCC will organise a trial for all solo classes to be held under the national sporting code of the ACU, the standing regulations for trials, these supplementary regulations and any final instructions which may be issued.

**Eligibility-** All riders must be a member of a current ACU affiliated club and must be able to produce a current ACU Trials Registration card.

**Entries:-** Limited entry, close when full. Pre-entry or enter on day until entry limit is hit.

**Entry Fees:-**

£15 for Monday Time and Observation Trial

Entries will only be returned if the trial is cancelled or on request if postponed for more than 24 hours.

**Venue:-** The start will be at Gesail Ddu, Foel, Powys, signposted off the A458, 20 miles West of Welshpool

**Start Time & Order:-** Trial will be split to separate youth and adults.

The Adult Trial will start at 12am, riders will be sent off in 30 second intervals. A time limit of 1¾ hours to complete the course. Riders finish their time at the last section.

Youth Trial will start at 2pm, riders will be sent off in 30 second intervals. A time limit of 1¾ hours to complete the course. Riders finish their time at the last section.

Youth riders will observe for adults, then adults will observe for youth.

**Course:-** 4 laps of approx 8 sections, based loosely around the first 8 sections of the Forest Trophy Trial. All riders follow Red/Blue route, Blue on Left, Red on Right. Course severity will be aimed at clubman yellow level.

**Method of marking/scoring:-** The TSR22b method of marking (stop with no penalty) will be used. Fastest rider will set "Standard Time". All other riders will lose one mark per minute over that time. Their time score will then be added to their observation score.

Riders will score a 5 for contact with another rider or machine. Riders must make a valid attempt at all sections or will be excluded.

**Results:-** Results will be available via the Llanfyllin website [www.trialspace.co.uk](http://www.trialspace.co.uk) as soon as possible after the trial.
